The company operates from a 15-acre site in Wormingford in Colchester

We handle over 75,000 tonnes of waste per annum which passes through one of our two M.R.F.s (Materials Reclamation Facility) allowing us to better divert waste from landfill.

Our first-class recycling service is part of our efforts to provide a cleaner, greener future for the next generation.

Our M.R.F.s are designed to handle mixed municipal waste, construction waste and pre-segregated recyclables.

Materials are sorted into the various grades required to feed into the recycling chain, CSH Recycling equipment includes Bag Opener, Baling Equipment, Picking Line, Magnets, Shredders', wheeled material handlers and dedicated bays and containers for all types of recyclable materials.

CSH Operate a trommel, which is a rotating cylindrical screen which assists in the recovery of useful fractions from building waste. This along with our Soil Shaker allows us to separate various grades of hard core and soils.

We currently separate, re-use, recycle or repurpose more than forty different types of material.

With these facilities, we are able to divert around 99% of all the waste we collect away from landfill. Here are some of the materials that we work with at our centres through our recycling services:




We also recycle Hardcore, Metal, Soil, Plasterboard and Food Waste

Zero to Landfill – Our advanced Recycling Centre ensures that everything that can get recycled – does get recycled.

Over the course of a year, our recycling figures include handling over 80,000 tonnes of waste through our various services including skip hire, wheelie bin hire and trade waste collection service. Of the waste we collect, our aim is to recycle at least 99% of it and prevent it from being left in landfill sites.

Essex Young Farmers Recycling Campaign

Here at CSH Environmental, we're committed to making good use of the waste we collect from all sources – our <u>latest figures</u> show that over 99.7% of the waste we collected in 2024 went for recycling or for creating energy.

How CSH Environmental supports EYFC

Each year, we work with Essex Young Farmers Club (EYFC) to improve the amount of agricultural waste being reused and recycled while also raising much needed resources for local branches.

Traditionally, much of the waste generated in the agricultural industry – such as cardboard packaging and woven PP bulk bags – has been sent to landfill rather than being collected for recycling. Our campaign is designed to promote a more eco-friendly approach to dealing with agricultural waste while also raising funds for EYFC.

The scheme is very simple: as we recover certain waste materials from local farmers for recycling, we'll make a donation to EYFC to help them support rural communities in our county.

The waste materials that are included in this scheme are:

- Cardboard packaging
- Clean or washed chemical cans and agricultural containers
- Fertiliser and seed bags (PP woven sacks)

In 2024, we raised £12,800 and in 2024 we were delighted to raise £16,900 for Essex Young Farmers Club through this innovative scheme.
